### INVITATION OF BIDS

Tenders should be submitted prior to the last date of the submission.

Bihar School Examination Board, **reserves the right to accept or reject in part or full any or all the offers without assigning any reasons whatsoever. No consortium bidding is allowed.**

2. **Bid Submission:** The Bids should be submitted in two parts i.e. Technical Bid and Financial Bid.

**Technical Bid:** - The Technical Bid should be submitted in separate envelop.

**Financial Bid:** - The Financial Bid should be submitted in separate envelop.

## SECTION-II

### ELIGIBILITY CRITERIA

Bidders are advised to study all requirements, check lists and other information in the tender document carefully before submission of the proposal.

The bidder should have the below list of eligibility criteria to take participate in the bid.

- a) The bidder must have GST Number (Registration Number of the Firm/ Company/ Agency) PAN of Firm/ Company/ Agency/ Society.

- d) The bidder must have to submit **Rs. 500/-** (non-refundable) towards the cost of the Tender Document in the form of DD in favour of “Secretary, Bihar School Examination Board, Patna”.
- e) Delivery Time line is the essence of this tender (within 7 Days of getting the work order.)

## **SECTION-V**

### **FINANCIAL IMPLICATIONS**
