# **SECTION-I**

## **INVITATION OF BIDS**

### **1. Introduction**

Bihar School Examination Board (BSEB) invites short term sealed Tender from Distributors/Channel Partners/OEMs/System Integrator for supply, installation and configuration of IT Hardware & Software for Bihar School Examination Board, Patna, Bihar.

**Brief description of Works:** Supply, Installation and Configuration Hardware & Software for Bihar School Examination Board.

**Location of Delivery:** Bihar School Examination Board, Sinha Library Road, Patna –800017, Bihar

Sealed tenders should be submitted prior to the last date of the submission.

Bihar School Examination Board, **reserves the right to accept or reject in part or full any or all the offers without assigning any reasons whatsoever. No consortium bidding is allowed.**

### **Bid Submission**

The Bids should be submitted in two parts i.e. Technical Bid and Financial Bid.

**Technical Bid:-** The Technical Bid should be put in a single sealed cover super scribing the wordings “Technical Bid” for supply, installation and configuration of IT Hardware & Software for Bihar School Examination Board, Patna. The EMD/ Tender form fee must be enclosed with the technical bid.

**Financial Bid:-** Financial Bid should be put in a single sealed cover super scribing the wordings “Financial Bid” for supply, installation and configuration of IT Hardware & Software for Bihar School Examination Board, Patna.

## **SECTION-II**

### **ELIGIBILITY CRITERIA**

Bidders are advised to study all requirements, check lists and other information in the tender document carefully before submission of the proposal.

The bidder should have the below list of eligibility criteria to take participate in the bid.

- a) The company should be registered with the Sales Tax Authority. The bidder has to provide Sale Tax Registration Certificate & PAN copy.
- b) The bidder should have an average annual turnover of at least Rs. 1 Crore (One Crore) in similar work during last three Financial Years (2012-2013, 2013-2014, 2014-2015).
- c) The bidder has to provide a self-certified letter by the authorized signatory of the bidder that the bidder has not been blacklisted by any Central / State Government.
- d) The bidder must have to submit Rs.50/- (non-refundable) towards the cost of the Tender Document in the form of DD in favor of “Secretary, Bihar School Examination Board, Patna”
- e) The bidder must have to submit Rs.25000/- (refundable) towards the cost of the EMD in the form of DD in favor of “Secretary, Bihar School Examination Board, Patna”.
- f) The bidder has to submit all the details in the prescribed format given in the Annexures with the Seal and Authorized signature in each page.
- g) The bidder has to submit the OEM Authorization letter for supplying the Hardware & Software equipment.

#### **Important Points: -**

- (a) In absence of any one of the above, the offer will be treated as non-responsive and summarily rejected.
- (b) Relevant documents in support of the above criteria must be enclosed along with Tender Call documents failing which the bid will liable to be rejected.
- (c) The Tender Call documents of the vendors, unsuccessful in Pre-Qualification/eligibility criteria shall not be considered for evaluation.

## **SECTION- III**

### **SCOPE OF WORK**

#### **1. Scope**

- a) Supply, Installation and Configuration of IT Hardware equipment (Desktop Systems, Laptops, Multifunctional Printers, UPS etc.) for Bihar School Examination Board, Patna.
- b) Supply, Installation and Configuration of Software (Operating System, Microsoft Office Professional, etc.) for Bihar School Examination Board, Patna.
- c) Bidder needs to provide comprehensive 3-year warranty support (3/3/3 on-site/ labour/ spare parts) for all the supplied products as per the mentioned specification. Bidder needs to prepare and submit the proposal regarding the plan, escalation matrix of providing the support as per the requirement.
- d) The bidder should provide the information of the equipment including the warranty details during delivery of materials.
- e) The service escalation matrix with the details of the concerned personnel of the bidder must be furnished with bid.
- f) The bidder has to arrange support to response the issue relating to the above IT Assets within 24 Hours and resolution period must be less than 72 Hours. 0.25% of equipment value per day will be deducted from the security deposit after 72 Hrs. (The hours mention above is exclusive of Sunday & Government Holidays).
- g) The Computer and laptops should be supplied along with software like- Operating System (Windows-10 Professional) and Licensed MS-Office 2016 Professional along with other utility software like Adobe reader etc.

### **BID EVALUATION**

#### **1.1 Technical Evaluation Criteria**

Criteria for evaluation of technical bids have been specified below of this section:

- i. The technical evaluation will be done only on the basis of the specifications provided in the bid document.
- ii. The commercial bids of only the technically qualified bidders will be opened for further processing.

#### **1.2 Evaluation of Financial bid**

Lowest Financial bid will be adopted for selection of the bidder

- i. The Financial Bids of the technically qualified bidders will be opened on the prescribed date.
- ii. Only fixed price financial bids indicating total price for all the deliverables and services specified in this bid document will be considered.
- iii. The bid price will include all taxes and levies and shall be in Indian Rupees.
- iv. Errors & Rectification: Arithmetical errors will be rectified on there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail”.

## **SECTION-V**

### **Financial Implications**

The Financial Implication shall be provided in the below mentioned format and in the attached format mentioned in **Annexure 3 (Price Schedule)**:

Our financial proposal shall be binding upon us subject to any modifications resulting from contract negotiations, up to the expiration of the validity period of the proposal, i.e. 90 (days).

- i. No advance payment will be made under any circumstances.
- ii. The payment to the respondent shall be made by BSEB, Patna based on the services provided by the respondent to the BSEB, Patna as per the Scope of Work under this Tender and the Contract signed between the respondent and the BSEB, Patna.
- iii. One payments will be made in Indian Rupee Only.
- iv. The payment would be made as per the following table on submission of invoice by the Vendor to the Bihar School Examination Board, Patna. Payment would be released within 7 days.

## **SECTION-VI**

### **GENERAL TERMS & CONDITIONS**

- i. In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to the sole arbitration of **The Chairperson, Bihar School Examination Board, Patna** or his Nominee. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the Chairman, Bihar School Examination Board, Patna or by whatever designation such officers may be called (hereinafter referred to as the said officer) and if the Chairman, Bihar School Examination Board, Patna or the said officer is unable or unwilling to act as such, then to the sole arbitration of some other person appointed by the Chairman, Board of School Education Bihar or the said officer.
- ii. The venue of the arbitration proceeding shall be Office of the Chairman, Bihar School Examination Board, Patna or such other place as the arbitrator may decide.
- iii. Successful tenderers have to execute an agreement on stamp paper of Rs.1000/- as token of having accepted the rates, terms and conditions of this Contract.
- iv. Tenders without Earnest Money Deposit will not be accepted. EMD is to be paid by a DD only. Payment by any other mode except DD towards Earnest Money Deposit is not acceptable.
- v. If a Tenderer withdraws their offer after submission and before acceptance of their tender, then the Earnest Money deposited by him is liable to be forfeited.
- vi. Bihar School Examination Board, Patna, reserves the right to accept or reject any tender in part or full at their discretion without assigning any reason.
- vii. The offers should be in full conformity with the terms and condition of this tender. Incorrect and incomplete tenders will be rejected.
- viii. Tenders not submitted on the prescribed forms will be rejected.
- ix. If a tenderer deliberately gives wrong information in his tender or creates conditions favorable for the acceptance of his tender, Bihar School Examination Board, Patna, reserves the right to reject such tender at any stage.
- x. Three years onsite comprehensive warranty(3/3/3 on-site/ labour/ spare parts)on All Product by the Vendor.
- xi. 24\*7 Support till 3 years related to Desktop, Laptops, Printers and UPS person will come to Bihar School Examination Board, Patna office (Both Premises – Sinha Library &

Buddh Marg) to solve the issue. If any issue comes then within 3 working days to be solved.

- xii. The Bidder has to give undertaking that proposed/offered make & model are as per the specifications given in the tender documents.

### **1. Relationship between the Parties**

Nothing mentioned herein shall be constructed as relationship of master and servant or of principal and agent as between the Bihar School Examination Board, Patna and the Vendor. The Vendor subject to this contract has complete charge of personnel, performing the services under this project from time to time. The Vendor shall be fully (jointly and severally) responsible for the services performed by them or on their behalf hereunder.

### **2. Delivery and Documents**

The Vendor shall submit all the deliverables on due date as per the delivery schedule.

### **3. Payment Schedule**

The Payments would be made to the bidder and bidder would be the single point of contact for Bihar School Examination Board, Patna. No payment shall be made for partial work done. Payment will be made in phases as per the payment terms given in “Payment Term LD Charges”.

If not installed and commissioned within 15 days after receiving the LOI.5% will deducted from the total charges given in the tender

### **4. Taxes and Duties**

The company shall be solely responsible for the payment of all taxes and duties, license fees, octroi etc. incurred until completion of the job in all respect. However, VAT or Bihar Sales Tax will be deducted at source at the prevailing rates in Bihar. The rates quoted must be inclusive of all Taxes as applicable.

### **5. General Terms and Condition**

Submission of bid against this offer shall bind the bidder for the acceptance of all the conditions specified herein by the BOARD.

### **6. Forfeiture of EMD**

EMD submitted by the vendor may be forfeited under the following conditions. If the bid or its submission is not in conformity with the instruction mentioned herein;

- i. If the vendor withdraws the tender before the expiry of the validity period.
- ii. If the vendor violates any of the provisions of the terms and conditions of the tender in the case of a successful vendor fails to
  - a) Accept award of work,
  - b) Sign the contract agreement with Bihar School Examination Board, Patna, after acceptance of communication on placement of award,

- c) Furnish performance security, or the vendor violates any of such important conditions of this tender document or indulges in any such activities as would jeopardize the interest of Bihar School Examination Board, Patna in timely finalization of this tender.
- iii. The decision of Bihar School Examination Board, Patna regarding forfeiture of bid security shall be final and shall not be called upon question under any circumstances. A default in such a case may involve black-listing of the vendor by Bihar School Examination Board, Patna.
